

2008 House of Delegates Roll Call Votes

1. **Captive Audience Bill**- Prohibiting employers from mandating captive meetings with their employees relating to political matters. Same standard doesn't apply to labor unions and this legislation would create. (HB 4132) 2/25/08 RC#106 (64-33)
2. **Gambling hotline** returned to HHR after a possible conflict of interest under the Lottery Commission where they may have sought to minimize the negative effects of gambling. (HB 4402) 2/25/08 RC#149 (96-0)
3. **Making Stalking a Criminal Offense** that included "following, observing or monitoring" when done more than once. This could apply to many non criminal, non threatening activities. (HB 4484) 2/26/08 RC#190 (77-22)
4. **Making false allegation** in child custody cases. The purpose of this bill is to make it a crime for falsely reporting child abuse or neglect cases, sexual abuse or domestic violence, and to provide civil liability. A parent who makes a false statement in order to gain a favorable custody decision will now be held accountable. (HB 3065) 2/27/08 RC#218 (85-13) (See also RC#352)
5. **Castle Doctrine** to allow a person not engaged in unlawful activities to use deadly force against an intruder or attacker for self defense. (SB 145) 2/28/08 RC#241 (96-1)
6. **Funding Two Greyhound Training Tracks** up to \$2 million rather than the existing law that required only one be funded. (HB 4307) 3/8/08 RC#505 (72-24) (See also RC#222)
7. **Election bill – postpone indefinitely** or until after the pending election when more time is available to analysis and study other similar court decisions. This issue was introduced in a special session geared originally for other topics and smelled of back room political maneuvering in an effort to silence watchdog groups from getting vital information out about candidates. (HB 219) 6/25/08 RC#628 (20-65) (See Roll Call 629)
8. **Election bill – amend to match up with Judge Faber decision** with similar language regarding print and broadcast definitions. The 4th Circuit Court had a similar ruling on North Carolina case. This bill included legislative findings without scientific or empirical information, but instead used antidotal or individual hearsay. On October 2008, as predicted, a federal judge struck down this law as a violation of free speech guaranteed under the U.S. Constitution. This political tactic will be geared toward stifling the free flow of information about candidates positions and cost the taxpayers thousand of dollars, in addition to the cost for the June extended special session. (HB 219) 6/26/08 RC#629 (25-60)
9. **Election bill – eliminate vagueness** from Election bill – "reasonable person" vagueness deleted. Vagueness would chill political speech as too broad, vague and undefined. (HB219) 6/26/08 RC#630 (22-63)
10. **Election bill passage** This bill was a politic tactic geared to stifle the free flow of information and thereby deny groups the ability to get out critical information on candidate's voting records and public positions. In October, as predicted, a federal judge struck down this law as a violation of free speech. This political tactic will end up costing the taxpayers thousands of dollars, in addition to the cost of the June extended special session. (HB219) 6/26/08 RC#636 (67-21)

Committee Votes - House Judiciary Committee

11. **Sexual Orientation** – Would add to the WV Human Rights Act "civil rights" status to homosexuals, lesbians, bi-sexuals, and transgendered individuals. Employers and landlords would be forced to hire and rent to those who choose to live these sexual lifestyles and enforcement powers would be granted to the WV Human Rights Commission to penalize those who refused. (SB 600) 3-5-08 (14-7)
